This signed Authority and Mandate refers to our contract as dated as on signature hereof ("the Agreement"). I / We hereby authorise you to issue and deliver payment instructions to the bank for collection against my / our abovementioned account at my / our above mentioned bank (or any other bank or branch to which I / We may transfer my / our account) on condition that the sum of such payment instructions will never exceed my / our obligations as agreed to in the Agreement, and commencing on the commencement date and continuing until this Authority and Mandate is terminated by me / us by giving you notice in writing of no less than 20 ordinary working days, and sent by prepaid registered post or delivered to your address indicated above. The individual payment instructions so authorised to be issued must be issued and delivered as follows:

On the first day of each and every month commencing on _____. In the event that the payment day falls on a Saturday, Sunday or recognized South African public holiday, the payment day will automatically be the very next ordinary business day. Further, if there are insufficient funds in the nominated account to meet the obligation, you are entitled to track my account and re-present the instruction for payment as soon as sufficient funds are available in my account.

I / We understand that the withdrawals hereby authorised will be processed through a computerized system provided by the South African Banks and I also understand that details of each withdrawal will be printed on my bank statement. Each transaction will contain a number, which must be included in the said payment instruction and if provided to you should enable you to identify the Agreement. A payment reference is added to this form before the issuing of any payment instruction. I / We shall not be entitled to any refund of amounts which you have withdrawn while this authority was in force, if such amounts were legally owing to you.

Mandate

I / We acknowledge that all payment instructions issued by you shall be treated by my/our above mentioned bank as if the instructions had been issued by me/us personally.

Cancellation

I / We agree that although this Authority and Mandate may be cancelled by me / us, such cancellation will not cancel the Agreement. I / We shall not be entitled to any refund of amounts which you have withdrawn while this authority was in force, if such amounts were legally owing to you.

Assignment

I / We acknowledge that this Authority and Mandate has been ceded to Netcash (Pty) Ltd as per your agreement with Netcash (Pty) Ltd, but in the absence of such assignment of the Agreement, this Authority and Mandate will be null and void.

TERMS AND CONDITIONS

Club Services

Lift Club your 24hr Family Transport Club.

Members call the 24hour call centre and request either a chauffeur or club car. A chauffeur will transport members to their final destination. Chauffeurs are only permitted to transport members in their own cars (members car) to their final destination. Club cars collect and lift members to their desired destinations.

Whenever a member uses the clubs services he/she would need to sign a Club usage form. This would be invoiced to members at the end of the month. Upon the arrival of Lift Club at a member's collection address Lift Club is permitted to wait up to 10 minutes there after can leave and member will be charged for the call out. In respect of time taken from placing call at call centre to the actual arrival of Lift Club, members allow Lift Club 30mins. (The aforementioned time is not a guarantee)

Charges and Payment for Services

Members shall pay to Lift Club membership fees, monthly in advance and monthly in arrears for the total charges incurred by members in respect of club usage fees. Members accept club usage fees and monthly membership fees, to be fair and reasonable as contained herein and consents to increases from time to time. Lift Club will always try to give prior notice to members of any price increases, but gives no guarantee in this regard.

Debit Order instruction

Members hereby authorise Lift Club to draw against their bank account all charges incurred in respect of services and membership fees in accordance with applicable fees as amended from time to time. All such debits from members bank accounts shall be affected by no sooner than the 28th day of every month and not later than the 3rd day of the month proceeding the month which the usage services were used. All such debits from members bank accounts shall be treated as though they were signed by the member personally. Members agree to pay any bank charges and processing costs relating to this debit order instruction.

Duration of agreement

This Agreement will be effective from the date of signature and shall remain effective for 12 months from date thereof.

Expiration of Agreement

After the initial twelve months/initial period has expired, the agreement will be automatically renewed for a further period equivalent to the initial period, provided that termination/cancellation can be effected by members or Lift Club serving one months notice in writing by registered post, not later than (30) days before initial period has been concluded. All parties agree understand and agree that Lift Club has the right to terminate agreement at any time if feels fit, at its sole discretion, on one months written notice to member. In this case Lift Club will reimburse members on all payments which were made in advance on the date of termination.

Indemnification

Members fully agree to indemnify Lift Club and all its members from being held responsible or liable for any damage, death, loss or injury, directly or indirectly, consequential or otherwise arising from the club services rendered. Lift Club promises to take reasonable care in providing it members with club services referred to in the above paragraph. Members hereby irrevocably indemnify Lift Club and the (Sole Proprietor) and all its employees against any claim which may be instituted against any one or more of them by a Member, his estate or successors in title arising out of or in connection with any negligent conduct of Lift Club (Sole Proprietor) and employees. Such indemnification does not apply where the conduct of Lift Club (Sole proprietor) and its employees conduct themselves in a reckless or intentional manner. Members further irrevocably indemnify Lift Club (Sole Proprietor) and employees from any claim which may be instituted against any one or more of them by a further passenger who is transported together with a member and by Lift Club at the request of the member. Members acknowledge that club services rendered by Lift Club in terms of this contract/agreement will be for members use only.

Lift Club does not guarantee members against unforeseen eventualities or possibilities which may prevent Lift Club from fulfilling its obligations in entirety. Members agree to provide their full cooperation, at all time towards Lift Club in order to complete their service.

Members warrant that appropriate insurance cover is in place in respect of the members motor vehicle and that their insurance extends to alternative drivers and alternative drivers under the age of 25years driving the members motor vehicle so as to include any Lift Club service provider.

Outstanding membership and Club usage fees

Members agree to pay any costs incurred by Lift Club for the collection of outstanding monies owed to Lift Club by particular member.

Cession

All parties agree that Lift Club is entitled to cede part or all of its obligations outlined in this contract and has the right to assign any or all these rights acquired in terms of this contract at any time and to any entity.
